### 2009 JFA Inc ANTI-DOPING POLICY MAJOR CHANGES

WADA amended their anti-doping code, the IJF amended their anti-doping rules and the JFA Inc complies with both with the introduction of the 2009 JFA Inc Anti-Doping Policy effective 1 January.

# **Test Planning**

- Greater emphasis on target testing
- Sample collection to include a balance between urine and blood testing

## **Sample Collection**

- Athlete now required to report immediately to the Doping Control Station unless the athlete requests a delay in reporting for a valid reason.

- The DCO or Chaperone may, at their discretion, grant such permission if the athlete can be continuously chaperoned and kept under direct supervision during the delay and the request relates to the following activities:

#### In Competition:

- a) participation in a victory ceremony
- b) fulfilment of media commitments
- c) competing further competitions
- d) performing a warm down
- e) obtaining necessary medical treatment
- f) locating a representative and/or interpreter
- g) obtaining photo identification
- h) any other exceptional circumstances which can be justified

#### Out of Competition:

- a) locating a representative
- b) completing a training session
- c) receiving necessary medical treatment
- d) obtaining photo identification
- e) any other exceptional circumstances which can be justified
- The sample provided by the *athlete* to the Sample Collection Personnel should be the first urine passed by the *athlete* subsequent to notification.
- Athletes who are *minors* may be accompanied by a representative throughout the entire sample collection session.
- Minor athletes' representatives may only directly witness sample provision if requested by the minor
- If a minor does not have a representative present in the toilet area, a second ASADA official will observe the sample collection process without directly observing the sample provision.
- There is no limit on the number o samples to be collected if the Specific Gravity is too low (<1.005). Athletes should avoid over re-hydration to avoid this.

ASADA's travel policy states it is the athletes' responsibility to take into consideration the possibility of post event testing when making travel arrangements and advise not to arrange travel immediately after an event. This has not changed but is just a reinforcement to the athlete.

#### **Prohibited List**

- All substances are now specified except:
  - o Anabolic Agents
  - o Hormones and related substances
  - Myostatin inhibitors
  - Non-specified stimulants
  - o Prohibited methods

# **Results Management**

- Shorter time frames (B sample to be tested within 7 days)
- Mandatory provisional suspensions for non-specified substances
